Few other schemes were also implemented through reimbursement to MSEs in the field of National and International Product & Energy Certification, Reimbursement towards participation in National and International Trade Fairs were also made to the applicant MSE units during this year.

This report in this form of Compendium of NMCP & other schemes implemented by this Institute has been compiled for the year 2013-14. I do hope that the report may be useful for reference purpose and assessing performance of Individual Institute for implementation of NMCP Scheme.

National Manufacturing Competitiveness Programme (NMCP)

The National Manufacturing Competitiveness Programme is the nodal programme of the Government of India to develop global competitiveness among Indian MSMEs. Conceptualised by the National Manufacturing Competitiveness Council, this Programme was initiated in 2007-08. There are ten components under the NMCP scheme targeted at enhancing the competitiveness for the entire value chain of the Micro, Small and Medium Enterprises (MSME) sector. They are:

- a. *Marketing Assistance/Support to MSEs (Bar Code):*** The objective of the ‘Marketing Assistance/Support to MSEs scheme of NMCP is to popularize the Bar Code registration and motivate the Small and Micro-manufacturing Enterprises to adopt the Bar Code Certification on large scale and to sell their value added products worldwide and enable higher export price realization. It also helps in domestic marketing (wholesale & retail). 75% of one time registration fee and 75% of annual recurring fee for the first three years paid by MSEs to GS1 for use of Bar Code is reimbursed to Micro and Small Entrepreneurs under this Scheme.
- b. *Scheme for Providing Support for Entrepreneurial and Managerial Development of SMEs through Incubators:*** The scheme aims at nurturing innovative business ideas (new/indigenous technology, processes, products, procedures, etc.), which could be commercialized in a year. Under the scheme, various institutions like Engineering Colleges, Research Labs etc. will be provided funds upto Rs. 6.25 lakh for handholding each new idea/entrepreneur. The incubator will provide technology guidance, Workshop and Lab support and linkage to other agencies for successful launching of the Business and guide the entrepreneur in establishing the enterprise.
- c. *Enabling Manufacturing Sector to be Competitive through Quality Management Standards (QMS) and Quality Technology Tools (QTT):*** During the year 2008-09, Government of India launched the scheme ‘Enabling Manufacturing Sector to be Competitive through Quality Management Standards (QMS) and Quality Technology Tools (QTT)’ in order to improve quality and productivity in the MSE sector. The scheme is aimed at improving the quality of the products in the MSE sector and inculcates the Quality consciousness in this sector. The major activities under this scheme are :

 - i. Introduction of Appropriate Modules for Technical Institution
 - ii. Organizing Awareness Campaigns for MSEs
 - iii. Organizing Competition-Watch (C-Watch)
 - iv. Implementation of Quality Management Standards and Quality Technology Tools in selected MSEs
 - v. Monitoring International Study Missions and
 - vi. Impact Studies of the initiatives.

- d. Building awareness on Intellectual Property Rights for the Micro, Small and Medium Enterprises (MSMEs):** The Scheme for “Building Awareness on Intellectual Property Rights (IPR), for the Micro, Small and Medium Enterprises (MSMEs) has been launched to enable Indian MSMEs to attain global leadership position and to empower them in using effectively the tools of Intellectual Property Rights (IPR) of innovative projects. The main features of this scheme includes
- i. Awareness/Sensitization Programmes on IPR
 - ii. Pilot Studies for Selected Clusters/Groups of Industries
 - iii. Interactive seminars/Workshops
 - iv. Specialized Training
 - v. Assistance for Grant on Patent/GI Registration
 - vi. Setting up of IP Facilitation Centre (IPFC) and
 - vii. Interaction with International Agencies. These initiatives are being developed through Public-Private Partnership (PPP) mode.
- e. Lean Manufacturing Competitiveness Scheme (LMCS) for MSMEs:** Under this scheme, MSMEs are being assisted in reducing their manufacturing costs through proper personnel management, better space utilization, scientific inventory management, improved process flows, reduced engineering time and so on. LMCS also brings improvement in the quality of products and lowers costs which are essential for competing in national and international markets. The total GoI contribution is stipulated as Rs. 26.3 crore (approx.) for this scheme. The broad activities planned under the scheme include implementation of Total Productive Maintenance (TPM), 5S, Visual Control, Standard Operation Procedures, Just in Time, Kanban System, Cellular Layout, Poka Yoke, TPM, etc. The Scheme has been approved as a pilot project for Lean interventions in 100 Mini Clusters.
- f. Design Clinics Scheme for MSMEs:** The main objective of the scheme is to bring the MSME sector and design expertise into a common platform and to provide expert advice and solutions on design problems, resulting in continuous improvement and value-addition for existing products. It also aims at value-added cost effective solutions. The GoI contribution is stipulated as Rs. 49.08 crore for this scheme. The broad activities planned under the scheme include set up of Design Clinics Centre in Delhi along with 4 regional centers for intervention on the design needs of the MSME sector, organizing seminar/workshops, financial assistance to student designed projects/individual projects upto 3 MSMEs/Group of MSMEs or more.

- g. Marketing Assistance and Technology Upgradation Scheme for MSMEs:** The objective of this scheme is to identify and encourage those clusters of MSMEs, which have quality production and export potential and assist them to achieve competitiveness in the national and international markets. The scheme aims at improving the marketing competitiveness of MSME sector by improving their techniques and technology for promotion of exports. The GoI contribution is stipulated as Rs. 18.6 crore for this scheme. The broad activities planned under the scheme include technology upgradation in packaging, development of modern marketing techniques, competition studies, corporate governance practices, setting up of marketing hubs, State/District level exhibitions etc.
- h. Technology and Quality Upgradation Support to MSMEs:** The objective of the Scheme is to sensitize the manufacturing (MSME) sector in India to upgrade their technologies, usage of energy efficient technologies to reduce emissions of Green House Gases, adoption of other technologies mandated as per the global standards, improve their quality and reduce cost of productions, etc., towards becoming globally competitive. The major activities planned under the scheme include Capacity Building of MSMEs Clusters for Energy Efficiency/Clean Development Interventions, Implementation of Energy Efficient Technologies in MSME sector, Setting up of Carbon credit aggregation centers and encouraging MSMEs to acquire product certification licenses from National/International bodies. The scheme total budget is Rs. 140.98 crore with GoI contribution of about Rs.65 crore.
- i. Promotion of Information & Communication Tools (ICT) in Indian Micro, Small and Medium Enterprises (MSME) Sector:** The objective of this scheme envisages that some of those clusters of SMEs, which have quality production and export potential, shall be identified & encouraged and assisted in adopting ICT applications to achieve competitiveness in the national and international markets. The total GoI contribution is stipulated as Rs. 47.7 crore (approx.) for this scheme. The broad activities planned under the scheme include, identifying target clusters for ICT intervention, setting up of e-readiness centre, developing web portals for clusters, skill development of MSME staff in ICT applications, preparation of local software solutions for MSMEs to enhance their competitiveness, and networking MSME cluster portals on the National Level Portal in order to outreach MSMEs into global markets.

Brief Report

of

National Workshop on Lean Manufacturing held at India Habitat Centre, New Delhi on 6.02.2014

One day Workshop on Experiences of Lean Manufacturing was organized by MSME Development Institute, New Delhi, on 6th February, 2014 at Jacranda Hall, India Habitat Centre, Lodi Road, New Delhi.

The Programme was inaugurated by Shri Madhav Lal, Secretary (MSME), Government of India at 10.00 a.m. Shri Ramaesh Kumar Pandey, Joint Development Commissioner (MSME) welcomed the Chief Guest, dignitaries on/off the dais, Representatives of MSME, Consultants and all the participants present in the Hall. Shri Amrendra Sinha, DC (MSME), Shri Amit Yadav, Industries Commissioner, NCT Delhi, Shri Vipin Sahni, CEO, NABET, QCI, Dr. S.K. Chakrovorty, DDG (NPC) were also present on dais during Inaugural Session.

Compendium of Success Stories of Lean Manufacturing Competitiveness Scheme was released by the Chief Guest. Shri Amrendra Sinha, D C (MSME) made presentation on “Lean Manufacturing and NMCP Schemes”. Shri Sinha emphasized on identifying more Industries and more number of clusters for Lean Implementation.

Shri S.K. Banerji, Consultant along with his associates Sh. Rohit Goyal of M/s. Reva Industries Ltd., and Sh. Amit Agarwal, M/s. Priyanshu Engg. Pvt. Ltd. made presentation on “Benefits Derived from Lean Implementation – Experiences through case studies of Auto Components & Light engineering Industries, CNC & Sheet Metal Cluster. Film Show was arranged to highlight the benefits after using Lean Tools like Kaizan, 5S, TPM. They also explained the challenges faced due to resistance from different corners during implementation of Lean. Mr. Goyal briefed that they have reduced inventory by 33% after implementation of Lean. It was also brought to the kind notice of audience that after implementation of Lean there was improvement in productivity, quality & manufacturing cost got substantially reduced. All stake holders of Sheet Metal Cluster, Light Engineering Cluster enlightened that the units have been benefitted by enormous monetary savings and their capabilities have got enhanced after implementation of Lean Tools.

Presentation of 4 years journey of Lean was made by Dr. S.K. Chakrovorty, DDG, NPC. Shri Chakravorty detailed about the non availability of consultants in early stage. He also detailed how 112 SPVs were formed during last 4 years. About 190 Nos. of consultants are empanelled with NPC for Lean Implementation. DSR for Lean Implementation in cluster was the most crucial stage. He told that all 5 phases were completed in 58 Nos. of clusters during last 4 years. 5000 Nos. of Kaizans have been implemented in last 4 years. Inventory cost has been reduced in most of the cases where Lean was implemented. About 10000 No. of employees have been trained during Lean implementation in Delhi/Chennai/Maharashtra/Gujarat. On an average there is annual savings of Rs. 1 crore/cluster. Rs. 3 crore/cluster has been earned by disposal of wastes/scrap. Shri chakravarty also described about training of 400 Nos. of LMCs during last 4 years.

Presentation on Relevance of Lean for Micro, Small & Medium Enterprises was made by Shri Vipin Sahni CEO-NABET, QCI. He explained about elimination of waste and improvement in Quality through Lean Implementation in different clusters functioning in the country.

Shri Madhav Lal, Secretary (MSME) during his Inaugural speech expressed his pleasure on successful implementation of the Lean Manufacturing competitiveness scheme covering various sectors across the country. He also shared his happiness over remarkable improvements in work place management, quality, safety, and delivery. He also informed about up-scaling of scheme by covering 500 mini clusters during 12th Five Year Plan. He stressed on need of strengthening Institutions/Associations for effective implementation of LMC Scheme.

Presentation on Experiences of lean in Auto Components & Light Engineering Industry and its benefits was made by Shri Rajiv Chawla, President Faridabad Small Industries Association. He emphasized on need of adopting world class practices. He advised MSEs to learn from their past mistakes. Importance of low cost automation, importance of value addition, knowledge and brand management, importance of retaining teams and retraining the employees were also detailed by Shri Chawla.

Presentation on sustaining competitive and responsible enterprises (SCORE) was made by Shri N.K. Murali, Shri K.C. Raghavan, Shri Shashank Kulkarni (Representatives of ILO). They emphasized on HR strategy, employees participation, energy saving, health and safety of employees, space utilization, employee retention etc.

Presentation on Lean approach for transformation was made by Shri Sanjay Jham. He explained the importance of 5S, Visual Management, Kaizen, standardization, Case studies were also presented.

Dr. Sarita Nagpal from CII made presentation on Lean Experiences in Small & Medium Sector. Presentation was made on the result in key cluster. Emphasis was given on Hospital Clean from inside and garden green from outside the unit. Presentation on salient features of new scheme of Lean Manufacturing for MSME was made by Shri A.K. Jain, Principal Advisor, QCI.

Ms. Pooja Makhija, Consultant detailed about Lean transformation and success story in Apparel cluster. Presentation was made on Waste elimination, inventory reduction by implementing Kaizen.

Success Story of Lean implementation in apparel industry was presented by Shri Manish and Shri Sandip Raina from Orient Fashions group. Presentation of skill matrix, training on multi skilled operations, and introduction of KANBAN System was detailed by them.

Shri R.C. Kesar from OGTC made his presentation on overall Lean Scenario in country.

Concluding Remarks were given by Shri Ramesh Kumar Pandey, JDC (MSME).

Vote of thanks was offered by Shri R.P. Vaishya, Director (MSME-DI, New Delhi).

Total no. of participants including Govt. officials, Stake Holders, Consultants and MSME representative were 225 Nos.

Workshop on Quality Management Standards & Quality Technology Tools (QMS/QTT)

Micro, Small & Medium Enterprises Development Institute (MSME-DI), Okhla, New Delhi organized one day Awareness cum sensitization programme on Quality Management Standards & Quality Technology Tools (QMS/QTT) on 25.03.2014 at Hotel Park Plaza, Sector 21-C, Faridabad (Haryana). This programme was organized in association with Faridabad Small Industries Association. The objective of the programme was to create awareness of Quality Management Standards & Quality Technology Tools among member units of Auto Cluster of Faridabad and motivate them to use the Quality Tools in their units for waste minimization, optimum use of manpower & machinery so that they could increase their productivity, reduce product cost without compromising product quality and without any investment as well.

The programme begun with welcome address by Shri Kamal Singh, Dy. Director (Mech.), MSME-DI, New Delhi. Apart from welcoming all the dignitaries, guest speakers and participants he outlined the objective of the programme. He said that by applying some techniques of QC Tools any organization can increase its productivity without any investment. He also cited some examples of those applying QC Tools in their units. He further said when the management of the organization applies these techniques there may be some resistance in the beginning but these tools are very useful in long term to run organization successfully.

Shri Rajive Chawla President, Faridabad Small Industries Association in his address highlighted the importance of Lean techniques in the industries specially engaged in auto components manufacturing unit where customer's satisfaction is utmost important. He shared his experiences of lean with the participants. He said that Lean management program was started as pilot in a cluster comprising twelve units of Faridabad to accelerate organizational learning and quickly build a foundation for organization wide change. He said that lean teams diagnosed problems in a small area, and then designed and implemented solutions, refined them along the way so they can be scaled up to their organizations. He informed that within 12 to 18 months, this approach delivered genuine transformations; typical improvements including better employee engagement & development and 15 to 30 percent rose in their productivity, 30 to 50 percent higher quality and service-level adherence and dramatically faster turnaround times and more customer satisfaction. He further said through this programme we want to spread the message of lean benefits among auto industrial unit so they can also join the campaign of lean. He said more than 50 clusters are expected to be formed in near future in Faridabad itself where lean techniques could be applied. He said Lean management also offers substantial risk-management benefits. He further said when managers understand more about the real needs of stakeholders and customers and eliminate non-value-added activities organizations can deploy human and financial resources to the areas where they can make more of difference. He said that with rapid test-and-learn events, managers should understand the implications of changes before rolling them out across the organization – and can make course corrections early and often. He expressed that standardizing work increases the predictability of outcomes and captures best practices. He added that creating a culture of transparency and constructive problem solving encourages staff to identify and mitigate risks and inefficiencies.

Sh.R .P. Vaishya Director, MSME-DI, New Delhi graced the occasion as Chief Guest and inaugurated the programme. In his inaugural address Shri R.P. Vaishya emphasized upon the proper awareness of various aspects of Quality Management Standards & Technology Tools. In his address he related QMS/QTT with lean manufacturing practices. He said that lean techniques initially was practiced with manufacturing industries but now it is being applied with equal emphasis in service as well as administration processes. He further said that lean is all about customer focus. He said that value is defined by the customer and the entity develops and maintains processes to provide this value and processes are run by people. He explained that the support, proper leadership and guidance drive people to continuously improve the processes that add value to the customer and the system that helps to achieve this is a Lean Management system. He further explained that Lean Management system uses various tools to connect the purpose (providing value to customer) to the process and people. He said that some of the lean management tools which are commonly used are Leader standard work, visual control boards, 5S, and daily accountability he explained in his address. He further added that owners of MSEs should have felling of responsibility towards customers and employees to improve their performance & overall productivity.

In pre-lunch technical session Shri A.K. Jain, Principal Advisor, Quality Council of India explained Quality Management Standards. He said that the Quality Management System is based on following eight principles:-

1. Customer Focus
2. Leadership
3. Involvement of peoples
4. Process approach
5. System approach to management
6. Continual improvement
7. Factual approach to decision making
8. Mutually beneficial supplier relationships

He explained above mentioned principles one by one in detail. He presented all the standards and their requirements in his presentation. He also gave many examples to explain the utility and benefits of quality management standards.

The post lunch session started with the presentation of Shri S.K. Bannerji, Sr. Lean consultant. He explained the following quality technology tools in detail:-

1. Check sheet
2. Cause & Effect Diagram
3. Pareto's Chart
4. Stratification
5. Histogram
6. Scatter Diagram
7. Graphs

He said, above seven quality tools have immense potential and bring turnaround in achieving favorable business results. He also explained the utility and benefits by giving appropriate examples.

Shri S. K. Bannerji also explained about lean techniques. He said that Lean Management System works on the following principles:

1. Value - specify what creates value from the customer's perspective.
2. The value stream – identify all the steps along the process chain.
3. Flow - make the value process flow.
4. Pull - make only what is needed by the customer (short term response to the customer's rate of demand).
5. Perfection - strive for perfection by continually attempting to produce exactly what the customer wants.

He also expressed that Lean Management System considers the following 7 types of manufacturing wastes (MUDA):

1. Overproduction – occurs when production should have stopped.
2. Waiting time – periods of inactivity.
3. Transport – unnecessary movement of materials.
4. Extra processing – rework and reprocessing.
5. Inventory – excess inventory not directly required for current orders.
6. Motion – extra steps taken by employees due to inefficient layout
7. Defective goods – don't conform to specifications or expectations.

He further explained about the following 7 types of service wastes (MUDA):

1. Delay – customers waiting for service.
2. Duplication – having to re-enter data, repeat details etc.
3. Unnecessary movement - poor ergonomics in the service encounter.
4. Unclear communication – having to seek clarification, confusion over use of product/service.
5. Incorrect inventory – out of stock.
6. Opportunity lost – to retain or win customers.
7. Errors – in the transaction, lost/damaged goods.

Sri Bannerji further expressed that the lean management leads to the following benefits at all levels.

1. Company – It ensures less waste which means low expenditure and investment. The reduction of waste will ensure improved product quality, profitability and optimized production.
2. Customers – It ensures improved customer care services and efficient supply of goods and services to clients.
3. Employees – It ensures motivated employees due to the safe working environment that the method avails to them.

Shri S.K. Bannerji also did some exercises on Quality Technology Tools for lean techniques to teach the participants.

The workshop concluded with vote of thanks proposed by representative of Faridabad Small Industries Association.
